

**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (MOU) is entered into, by and between the Kentucky Community and Technical College System (KCTCS) and Morehead State University (MSU).

In order to transition from the prior state postsecondary education tuition waiver program and continue the support of faculty and staff development, the undersigned have agreed to the following:


For semesters and sessions beginning after Spring Semester 2019 and ending before August 1, 2022, any employee of Morehead State University or the Kentucky Community and Technical College System shall be eligible to participate in a tuition discount program as described below.

KCTCS full-time employees attending MSU, and MSU full-time employees attending KCTCS colleges shall receive a 75% discount on each respective institution's tuition to any undergraduate or graduate program, excluding 800-level courses in doctoral programs, offered by the other party. Employees shall be responsible for the full cost of any applicable fees, which could include mandatory fees, program fees, or course/lab fees. Each semester, each course may be monitored to make sure that applicable revenue is present to cover the cost of instruction of a course. There shall be no cap on the number of credits per year.


MSU courses with NUR prefixes shall be subject to an amended arrangement for tuition discounting.

This program may be modified or discontinued at any time before August 1, 2022 by agreement of both parties.

(NURSING PROGRAM AMENDMENT)**

This Memorandum of Understanding (MOU) is entered into, by and between the Kentucky Community and Technical College System (KCTCS) and Morehead State University (MSU) specifically related to MSU Nursing Programs at the undergraduate and graduate level.

In order to transition from the prior state postsecondary education tuition waiver program and continue the support of faculty and staff development, the undersigned have agreed to the following:

For semesters and sessions beginning after Spring Semester 2019 and ending before August 1, 2022, any employee of Morehead State University or the Kentucky Community and Technical College System shall be eligible to participate in a tuition discount program as described below.


KCTCS full-time employees attending MSU and enrolled in nursing courses/laboratories, and MSU full-time employees attending KCTCS colleges in nursing courses/laboratories, shall receive a 50% discount on each respective institution's tuition to any undergraduate or graduate program offered by the other party. This amended MOU outlining a 50% discount applies to nursing prefix courses only. Employees shall be responsible for the full cost of any applicable fees, which could include mandatory fees, program fees, or course/lab fees. Each semester, each course may be monitored to make sure that applicable revenue is present to cover the cost of instruction of a course. There shall be no cap on the number of credits per year.

This program may be modified or discontinued at any time before August 1, 2022 by agreement of both parties.
