



Morehead Build-A-Bed

Frequently Asked Questions (FAQ)

The following FAQ should answer questions you may have about the Morehead Build-A-Bed project.

1. Am I eligible?

- a. You must have a child living in your household enrolled in school (3-18) who does not currently have a bed.
- b. You must meet the income guidelines listed on the application.
- c. You must have transportation to pick up the bed.
- d. You must have a bedroom in which the bed will fit and be utilized by the child.
- e. You must complete the application and submit it by the specified deadline.
- f. You must be a resident in one of the 25 counties in the service area.
- g. The following criteria will be considered when determining eligibility for awarded beds: age, income, number in household and current sleeping arrangements.

2. Who will receive beds?

- a. Bed recipients will be chosen based on the applications from 25 counties including: Bath, Bourbon, Bracken, Breathitt, Clark, Fleming, Floyd, Harrison, Johnson, Knott, Lee, Letcher, Lewis, Magoffin, Martin, Mason, Menifee, Montgomery, Morgan, Nicholas, Pike, Powell, Robertson, Rowan, and Wolfe.
- b. You may apply for more than one bed per household on the same application, but there is no guarantee you will receive a bed(s).

3. How do I apply?

- a. You can obtain an application on the MSUCorps website at: www.moreheadstate.edu/buildabed
- b. You can obtain an application from the MSUCorps Member or Family Resource Center at your child's school, or one of the partner agencies affiliated with the project.

4. What are the dimensions of the bed?

- a. The bed dimensions are: Height – 29 ³/₄ (Headboard), Width – 39 ¹/₂, Length – 81 ¹/₂

5. What comes with the bed?

- a. Each bed will have a frame, mattress, and a bedtime kit containing sheets, pillow, blanket, book, hygiene kit, and a stuffed animal.

6. Whom do I contact if I want to volunteer or donate?

- c. You can directly contact an MSUCorps Member or one of the partners listed, which include Retired Senior Volunteer Program (RSVP), MSU Office of Regional Education and Outreach, Gateway Homeless Coalition, and Frenchburg Job Corps CCC.

7. What is required to be a sponsor of Build-A-Bed?

- a. Donations of any size are accepted.
- b. A minimum of \$200 is required to sponsor a full bed.
- c. All donors will receive their name displayed on posters build day.
- d. Donor deadline to be acknowledged on posters is March 7, 2020.

8. Checks are made payable to whom?

9. Is my donation or sponsorship tax deductible?

- a. Yes, all donations and sponsorships are tax deductible. You will receive a tax receipt from Morehead State University.

10. What are the important dates pertaining to the Build-A-Bed project?

- a. Application deadline – February 14, 2020
- b. Sponsorship deadline to be on posters – March 7, 2020
- c. Bed build and distribution date – April 4, 2020
